This Instrument, or Policy of Insurance, witnesseth, That

whereas *Richard Holbrook of N. 25 Winchester Row, Paddington Gentlemen* has paid the Sum of *Twenty pounds and seven shillings* of lawful Money of Great Britain, into the Capital Joint Stock of the Westminster Society for Insurance of Lives and Survivorships, and for granting Annuities, and has agreed to pay, or cause to be paid, into the Capital Joint Stock of the said Society, at their Office in the City of Westminster, on the *sixteenth* Day of *October* in every subsequent Year, during the *natural Life* of the said *Richard Holbrook* the like yearly Sum of *Twenty pounds and seven shillings* for Insurance of the Sum of *Six Hundred Pounds* on the Life of the said *Richard Holbrook* now warranted in good Health, and not exceeding the Age of *Thirty-nine Years*, and of the Description set forth in a Certificate or Declaration signed by *the said Richard Holbrook* and dated th *is sixteenth* Day of *October* and lodged with the said Society.

And whereas the said *Richard Holbrook* has signed a Declaration of his Acceptance of the said Joint Stock, as his Security for the said Insurance.

Now know ye, That from the Date of these Presents, and in Case the said *Richard Holbrook* during his *natural Life* shall pay, or cause to be paid, the said yearly Sum of *Twenty pounds and seven shillings* at the Times and Place aforesaid, the Stock and Fund of the said Society shall be subject and liable to pay unto the Executors, Administrators, or Assigns, of the said *Richard Holbrook* the Sum of *Six Hundred Pounds* of lawful Money of Great Britain, within Three Calendar Months, after good and sufficient Proof shall be made upon Oath, or otherwise, as shall be required, to the Satisfaction of the said Society, of the Death of *him* the said *Richard Holbrook*.

Provided, That if the said *Richard Holbrook* shall at any Time or Times, before the Expiration of this Policy, depart beyond the Limits of Europe, or shall die upon the Seas, or enter into or engage in any Military or Naval Service whatsoever; or shall come by *his* Death by Suicide or Duelling; or if the Declaration above-mentioned contains any untrue Averment, That then, and in any or every such Case, this Policy, and every Thing herein contained, shall cease, determine, and be void and of none Effect.

In witness whereof, We, (Three of the Directors of the said Society), have hereunto set our Hands and Seals, this *sixteenth* Day of *October* in the Year of our Lord One Thousand Eight Hundred and *four*.
