**T**his Policy of Assurance Witnesseth, THAT Whereas *John Williams*  
of the Parish of *St. Andrew* in the County of *Worcester* Gentleman

being interested in the Life of *George Townshend Forester* of *St. Andrew* in the County aforesaid Esquire  
and being desirous of making an Assurance thereon for the Term of *Seven Years* hath subscribed, or caused to be subscribed,  
and delivered into this Office, a Declaration setting forth the ordinary and present state of Health of the said *George Townshend Forester*  
wherein it is declared that the Age of the said *George Townshend Forester* did not then exceed *Thirty Nine* Years;  
and having paid to the Trustees of the PELICAN LIFE-INSURANCE COMPANY, at their Office, in *LOMBARD STREET*, in the CITY of *LONDON*,  
the Sum of *Twenty One Pounds Nine Shillings and Twopence* as a Consideration for the Assurance  
of the Sum-undemtioned, for *One Year*, from the *Ninth* Day of *July* 1806.

Now Know all Men by these Presents, That in case the said *George Townshend Forester*  
shall happen to die at any Time within the Term of *One Year*, as above set forth, the Stock and Funds of this Company shall be subject and liable to pay and  
make good to the said *John Williams* his Executors, Administrators, or Assigns,  
within Three Months after the demise of the said *George Townshend Forester* shall have been duly certified  
to the Trustees aforesaid, at their said Office, the Sum of *One Thousand Pounds*  
of lawful Money of Great Britain.

AND it is hereby further agreed, that this Policy may be continued in force from YEAR TO YEAR, until the Expiration of the Term  
abovementioned, provided the said Assured shall duly pay or cause to be paid to the Trustees, at their said Office, on or before the *Ninth*  
Day of *July* next ensuing, the Sum of *Twenty One Pounds Nine Shillings and Twopence*  
and the like Sum Annually, on or before the Day aforesaid, which Annual Payments shall be accepted, at every such Period, as a full Consideration for such  
Assurance.

Provided Nevertheless, That should the said Assured depart beyond the limits of Europe, die upon the Seas, enter into, or  
engage in any Military or Naval Service whatsoever, within the Term for which this Policy is granted; or should the Assurance have been obtained  
through any misrepresentation of the Age, state of Health, or Description of the Assured; then this Policy, and every thing appertaining thereto, shall  
cease, be void and of none effect.
