**W**hereas

*Robert Clarke of Merton gentleman*

hath agreed to effect an Insurance upon the Life of *Thomas Robert Swinburn* against *Thomas Swinburn* with the NORWICH UNION LIFE INSURANCE SOCIETY, according to the Conditions prescribed by the Constitution thereof, and hath made a Declaration, setting forth the Age, and certain Particulars relative to the Health of the said Insured; **And whereas**, the Party effecting this Insurance hath paid to the said Society the Sum of £ 10. 11. 0 as a Premium for the first Year of such Insurance: **Now know all Men by these Presents**, that if the said *T. R. Swinburn* (during the life of *the said Thomas Swinburn*) shall die between the Day of the Date of this Policy, and the *seventy eighth* Day of *January 1883* inclusive, or in the Event of *his* living beyond the said Term, if the said *Robert Clarke his* Executors, Administrators, or Assigns, shall pay to the said Office the like Premium, on or before the *seventy eighth* Day of *January* in every subsequent Year of the Life of the Insured, the Funds and Property of the said Office shall be subject and liable to pay, within Three Calendar Months after satisfactory Proof of *his* Death, shall have been received by the Directors of the said Office, unto the said *Robert Clarke his* Executors, Administrators, or Assigns, the Sum of £ 700 " and such further Sum or Sums as shall at any Time or Times hereafter be appropriated under the Regulations of the said Office, as a Bonus upon this Policy: **Provided always**, that in Case it shall hereafter appear, that at the Time of the Delivery of this Policy on the Part and Behalf of the said Society, and the Receipt of the same, by, or on Account of the said *Robert Clarke T. R. Swinburn* the Party upon whose Life this Insurance is effected, was afflicted with Gout, Fits, Spitting of Blood, Asthma, or other Pulmonary Complaint, or any Disorder particularly tending to shorten the Duration of Life, or in Case *he* shall go upon the high Seas, (unless in passing direct from one part of the United Kingdom to another,) without previous Licence from the Court of Directors of the said Office so to do, or shall go beyond the Limits of Europe, or shall *enter* into any Military or Naval Service (the Militia or Volunteer Corps excepted,) without previous Licence from the said Court of Directors *for that purpose*, or if any Thing averred by the said *Robert Clarke* in the Declaration hereinbefore mentioned to have been made by *him* shall be untrue, this Policy shall be void, and the Monies paid on account of the said Insurance shall be forfeited to the Use of the Society.
