## POLICY OF LIFE INSURANCE.

Made by *Richard Thomas Bowtell* on his own Life.  
(For the whole Term.)

Whereas *Richard Thomas Bowtell* of N<sup>o</sup> 25, *Charlotte Street Fitzroy Square* in the Parish of *Saint Pancras* and County of *Middlesex*, *Tradesman*,

has made a proposal in writing for an ASSURANCE with the EUROPEAN LIFE INSURANCE COMPANY in the Sum of One hundred Pounds upon his own Life, and a Declaration has been made and delivered at the Office of the said Company, bearing date the first day of September, One Thousand Eight Hundred and thirty eight, setting forth, that the said *Richard Thomas Bowtell* was born at and in the Parish of *Christchurch* and City of *London* on the third day of May in the Year One Thousand eight Hundred and two and that his age, at his last birth day, did not exceed thirty six Years. That the said *Richard Thomas Bowtell* was then in good health; that he has had the Small Pox or Cow Pox; has not had the Gout; has not had Asthma; has not had a Rupture; has not suffered a spitting of Blood; has not had any Fit or Fits; was of sober and temperate Habits, and was not then afflicted with or subject to any Disorder tending to shorten Life.

And Whereas, the said *Richard Thomas Bowtell* hath paid at the Office of the said Company, for Insuring the said Sum of £ 100. 0. 0 the Sum of Two pounds sixteen shillings and six pence as a Premium for one whole Year, commencing on the seventh day of September One Thousand Eight Hundred and thirty eight.

Now We, the Undersigned, hereby Promise and Agree, That if the said *Richard Thomas Bowtell* shall die at any time on or before the sixth day of September, which will be in the Year of our Lord One Thousand Eight Hundred and thirty nine; or, if the said *Richard Thomas Bowtell* or his Assigns, shall in the event of his living beyond the said sixth day of September One Thousand Eight Hundred and thirty nine, pay at the Office of the said Company during his Life, the like Premium of £ 2. 17. 6 on or before the seventh day of September

in every Year, the Funds and Property of the said Company shall be subject and liable (according to the Provisions of the said Company's Deed of Settlement, bearing date the 10th day of July, 1820,) to pay and satisfy within Three Calendar Months after due proof shall have been received at the Office of the said Company of the Death of the said *Richard Thomas Bowtell* unto his Executors, Administrators, or Assigns, the Sum of One hundred Pounds and such farther sum or sums as shall under the Regulations of the said Company be appropriated as a bonus to this present Policy.

Provided always, That in case the said *Richard Thomas Bowtell* shall die upon the High Seas, (unless in passing direct from one part of the United Kingdom to another, or in passing from any part of the United Kingdom in time of Peace to and from any part of the Continent situate between the Elbe and Brest, in Steam or other decked Vessels,) without previous licence from the Court of Directors of the said Company to go upon the Seas, or shall go beyond the limits of Europe, or shall enter into any Military or Naval Service without previous licence from the said Court of Directors for that purpose; or shall die by Duelling, or by his own hands, or by the hands of Justice; or if any thing stated, either in the said Proposal or in the said Declaration hereinbefore mentioned, to have been made in this behalf, shall be untrue, this Policy shall be null and void, and all Premiums paid thereon shall become forfeited to the use of the said Company.
