CONDITIONS ON WHICH THE WITHIN POLICY IS GRANTED.

- r. Any material mis-description of any of the Property proposed to be hereby insured, or of any Building or Place in which Property to be so insured is contained, or any mis-statement of or omission to state any fact material to be known for estimating the risk, renders this Policy void as to the Property affected by such mis-description, mis-stateme
- If, after the risk has been undertaken by the Company, anything whereby the risk is increased be done to Property hereby insured, or to, upon, or in, any Building hereby insured, or any Building or Place in which Property hereby insured is contained, or if any Property hereby insured be removed from the Building or Place in which it is herein described as being contained, without, in each and every of such cases, the assent or sunction of the Company, signified by endorsement hereon, the Insurance as to the Property affected
- 3. This Policy does not cover Property held in trust or on Commission, unless expressly described as such; nor China, Glass, Lcoking Glasses, Jewels, Clocks, Watches, Trinkets, Medals, Curiosities, Manuscripts, Government Stamps, Prints, Paintings, Drawings, Sculptures, Musical, Mathematical or Philosophical Instruments, Patterns, Models or Moulds, unless specially mentioned in the Policy; nor Deeds, Bonds, Bills of Exchange, Promissory Notes, Money, Securities for Money, or Books of Account; nor Gunpowder; no Loss or Damage by Fire to Property occasioned by or happening through its own Spontaneous Fermentation or Heating, or by or through Invasion, Foreign Enemy, Riot or Civil Commotion; nor Loss or Damage by Explosion, except Loss or Damage by Explosion of Gas in a Building not forming part of any Gas Works.
- 4. This Policy ceases to be in force as to any Property hereby insured which shall pass from the Insured to any other person otherwise than by Will or operation of Law, unless notice thereof be given to the Company and the subsistence of the Insurance in favour of such other person be declared by a memorandum endorsed hereon by or on behalf of the Company.
- 5. On the happening of any Loss or Damage by Fire to any of the Property hereby insured the Insured is forthwith to give notice in writing thereof to the Company, and within fifteen days at latest to deliver to the Company as particular an account as may be reasonably practicable of the several articles or matters damaged or destroyed by Fire, with the estimated value of each of them respectively, beying regarded to their several values at the time of the Fire, and in support thereof to give all such vouchers, proofs and explanations as may be reasonably required, together with, if required, a statutory declaration of the truth of the account; and in default thereof no claim in respect of sach Loss or Damage shall be payable until such notice, account, proofs, and explanations respectively are given and produced, and such statut my declaration, if required, is made.
- If the claim he in any respect fraudulent, or if any false statutory declaration be made in support thereof, or if the Fire was
 occasioned by or through the procurement or connivance of the Insured, all beaefit under this Policy is forfeited.

- 7. The Company may, if it think fit, reinstate or replace Property damaged or destroy of instead of paying the amount of the Loss or Damage, and may join with any other Company or Insurers in so doing in cases where the Prope ty is also insured elsewhere.
- 8. On the happening of any Loss or Damage by Fire to any Property in respect of which a claim is or may be made under this Policy, the Company, without being deemed a wrong-doer, may by its authorised Officers and Servants enter into the Building or Place in which such Loss or Damage has happened, and for a reasonable time remain in possession thereof and of any Property hereby insured which is contained therein, for all reasonable purposes relating to or in connection with the Insurance hereby effected, and this Policy shall be evidence of leave and license for that purpose.
- If at the time of any Loss or Daniage by Fire happening to any Property hereby insured there be any other sabsisting Insurance ances, whether effected by the Insured or by any other person, covering the same Property, this Company shall not be liable to pay or contribute more than its rateable proportion of such Loss or Damage.
- 10. In all cases where any other subsisting Insurance or Insurances, whether effected by the Insured or by any other person, covering any Property hereby insured, either exclusively or together with any other Property in and subject to the same risk only shall be subject to average, the Insurance on such property under this Policy shall be subject to average in like manner.
- 11. If any difference shall at any time arise between the Company and the Insured or any claimant under this Policy as to the amount 11. If any difference shall at any time arise between the Company and the Insured or any claimant under this Policy as to the amount of any Loss or Damage by Fire, or as to the fulfilment of non-infilinent of any of the Conditions herein set forth, or as to any questions, matter, or thing concerning or arising out of this Insurable, every such difference, except in the case where fraud is alleged by the Company, as and whien the same arises, shall be referred to the arbitration and decision of two indifferent persons, one to be chosen by the party claiming and the other by the Company, or, in case of disagreement between them, then of an Umpire to be chosen by the Arbitrators before entering on the reference; and the costs of the reference shall be in the discretion of the Arbitrators or Umpire, as the case may be, who shall award by whom and in what manner the same shall be paid; and the decision of the Arbitrators or Umpire, as the case may be, shall be final and binding on all parties, and this condition shall be deemed and taken to be an Agreement to refer as descently
